


Nimble Fingers Stitch EHDOC Story

Critical Time for Senior Housing

The congress is currently engaged in debates over federal budget funding. The action regarding the FY 2011 budget significantly cut funding for affordable senior housing, Medicare, Medicaid and many other programs that assist EHDOC residents and other seniors and their families.

The funding bill that was passed just in time to prevent a threatened government shut-down drastically cut federal programs by nearly \$40 billion dollars compared to FY 2010 funding levels. Included in the cuts are affordable housing programs, health care, transportation, community services, and many other non-defense federal programs that assist the elderly, persons with disabilities, and other vulnerable families.

For the much needed Section 202 senior housing program that EHDOC and many other non-profit organizations have used in partnership with the federal government to provide quality affordable housing, the bill drastically cut this program from \$371 million for new construction in 2010 to \$78 million in 2011.

Despite the documented critical need for housing we have seen a continued downward trend in funding for new construction from a high in 2005 of \$650 Million which provided for 4,682 new units to the 2011 funding providing for less than 600 new units.

This dramatic decrease in new construction is countered with the dramatically increasing need. Today there are 10 eligible seniors waiting for very unit covered under this program. The housing programs are under assault and if we loose the battle to provide for new construction in 2012, the affects will be seen for many years as seniors, including the baby boomers face enormous housing shortages.

The FY 2012 budget is currently under debate. We know it will include cuts in federal programs to reduce federal deficit spending. But careful consideration must be made so that we do not try to balance a budget by eliminating or dramatically reducing programs aimed at providing housing and health care to our most at risk citizens. Affordable senior housing needs to be recognized as a sound, cost-effective investment in the quality of life and wellness of older persons.

Can we really afford to balance the budget on the backs of seniors?



The debate over the FY2012 federal budget is far from over. Congressional actions indicate that affordable senior housing and other programs that assist older persons are at serious risk of being dramatically cut and changed in ways that may be harmful to the elderly and other special needs populations.

Each of us knows from our household or professional budgets, that we cannot sustain deficit spending that keeps accumulating to a debt that could bankrupt us. We agree with the need for the Federal Government to reduce its deficit spending, to reduce the national debt, and to maintain a balanced budget.

The key issue is how it will be done. Who decides who will benefit or lose by any proposed change in spending priorities and policy changes? The outcome of these debates and policy decisions which will have significant impact not only on the federal programs that EHDOC and our residents depend upon for years to come, but also on the financial and economic stability of our community and country.

A key concern to EHDOC, our residents, potential residents and their families, is how well do the new Congressional members know and understand the various federal programs that are essential? Do they understand why these critical Section 202 senior housing programs should not be cut? Do they know who our Section 202 residents are? Their level and source of income? What their living condition is or how lack of housing will affect their physical well being? How important is affordable senior housing?

We must all make the effort to ensure our members of Congress know how important this program is. We are urging that before the next key votes that Congressional representatives visit EHDOC and other Section 202 facilities in their district or state to learn first-hand the cost effectiveness of this critically needed program and to put a human face on the need. Everyone should be involved in contacting elected representatives to urge funding for the Section 202 program and especially new construction of much needed senior housing. We have so drastically reduced the funding for new construction that with FY 2011 money only 594 units will be built. To put that in perspective, EHDOC has individual properties whose current waiting lists exceed that number.

There is no question that something needs to be done to get our financial house in order – to reduce deficit spending and to cut the national debt – but we cannot balance the budget on the backs of those who can least afford it.


Robert A. Georgine Tower Charlestown, MA

President's Comments

All Seniors are entitled to retirement with dignity

This fundamental objective was originally laid out more than 100 years ago by the early leaders of the American Labor Movement and has been a continuing objective throughout the years. There are essentially three corner stones to retirement with dignity – finances to provide for the necessities of life, affordable health care so that no health care need goes untreated and a decent place to live. Over the years, the first two have been taken care of with the passage of Social Security and Medicare. But, we maintain, that without a decent place to live there can be no dignity. Right now all three of these foundations are under attack.

In 2001 the National Council of Senior Citizens spun off its housing units into what became the Elderly Housing and Development Corporation (EHDOC). AFL-CIO President John Sweeney asked the then head of NCSC and former assistant to the President of the UAW. Steve Protulis, to take over the helm of the new organization. Since 2001 EHDOC has continued to champion the need for affordable senior housing -keeping to the original idea of retirement with dignity. EHDOC is proud of the great labor leaders serving on our board and are especially honored that Mark

Ayres, President of the AFL-CIO Building Trades Department, has joined our Board. His vision will be an asset as we continue to move forward.

We serve only one purpose – to provide safe and secure homes for those we serve each day is designed to make life a little better than the day before. Because of EHDOC's commitment and services we provide to our residents, we have an average five-year waiting list at our properties and one of lowest turnover rates in the nation. We in EHDOC, staff and residents, will be fighting alongside our colleagues in the AFL-CIO and Alliance for Retired Americans in the continuing battle to save Social Security and Medicare. This is a battle we all know we cannot lose. There is another battle we dare not lose. That is the one to see that sufficient funds are allocated for an increase in construction for low-income seniors. Our success will determine whether tens of thousands of low-income seniors can, indeed, enjoy their golden years. Without a decent place to live, that

critical part of the American dream will be lost to so many.

Recently, we invited one of our residents from a Miami building, an 85-year-old woman, to speak to our Board of Directors. She told us she hears us refer to "units" and "apartments" and other descriptions, but, she said, "This is my home. Each night when I lay my head on my pillow, I know I am at home and safe."

I submit to all of my trade union colleagues that at the end of the day, it is precisely this that we want for all Americans.


