### **Congress Passes Legislation to Improve Affordable Senior Housing**

ne of the last actions of the previous Congress was to pass legislation that would improve funding and the preservation of affordable senior housing. President Obama signed into law on January 4th, the "Section 202 Supportive Housing for the Elderly Act of 2010", that will bring about a number of reforms to one of the most successful federal senior housing programs.

EHDOC Executive Director, Steve Protulis, who testified before Congress in support of the legislation, praised the Section 202 program as one of the most important federal resources to enable non-profit organizations like EHDOC to provide quality affordable housing for millions of seniors. EHDOC has received national recognition for its effective use of the Section 202 program to develop and operate some of

the best quality senior housing in the country.

The new act will improve how the Section 202 program can be used with other state and local government resources to expand the number of senior housing apartments; as well as to attract resources to refinance existing Section 202 senior housing facilities. In addition, the act will enable additional resources to be available to improve the physical condition and to expand supportive services in existing Section 202 facilities.

Steve Protulis commended not only Congress and other national organizations who had provided leadership to get the law enacted, but also the many residents, family and friends of EHDOC senior housing facilities who had written and communicated with their Congressional members in support of this important legislation.


### How Long is the Wait?



The shortage of affordable senior housing becomes real when you look into the face of a senior who is desperately seeking housing. When they ask "how long is the wait?" and you know you to have to tell them it will be years you are face to face with a crisis.

I recall the 1,000 seniors who stood in line for the chance to get an application for Palermo Lakes, knowing only 109 of them would actually get housing. In California the day we opened John Piazza Apartments and moved in 60 seniors, we had another 35 already on a waiting list. And with the baby boomers turning 65 this year, the lists will grow longer. When I served on the congressionally appointed "Senior Housing Commission" in 2001-2002, the commission recommended 40,000 new housing units per year. Since 1979 we have been building less than 10% of that number.


It is this reality that causes great concern when proposed federal budget cuts would eliminate \$90 million from the senior housing new construction budget. With an already low allocation for new construction in the proposed



While we all recognize that the nation is facing record deficits, we cannot balance the budget on the backs of the poor, seniors, the disabled, and the disenfranchised. Properties for seniors and for the disabled are necessary and in the long run cost effective. Seniors living in EHDOC properties and other HUD Section 202 properties have greater disposable income for groceries, occasional movies, a new pair of shoes, or going to a restaurant, which is more than they would have if they had to spend their entire Social Security check on rent. This helps drive local economies. Construction of new senior housing creates jobs in the building trades and long term employment for site staff.

I am encouraged by the new Section 202 legislation that will make development of new housing more efficient. However these new procedures are of no use without proper funding to build new housing. With all of the discussions about debt reduction, we can never forget the impact those cuts would have on our most vulnerable citizens. Franklin D. Roosevelt once said "The test of our progress is not whether we add more to the abundance of those who have much; it is whether we provide enough for those who have little".

EHDOC will continue to be an advocate for affordable senior housing. Every one of us should be aware of this senior housing crisis and join together to make it a top priority in our nation.

# Healthcare The Time to Act is Now

merica's seniors have an enormous stake in what members of the newly elected House of Representatives are attempting to do with the health care reform bill passed last year. As this column is being written, efforts are underway to repeal the law. All Americans, particularly seniors, should be concerned by efforts that will dismantle the legislation piece by piece.

There has been considerable mis-information regarding the health care reform. Some of the information proffered by opponents has been designed to scare people, especially seniors, into opposing the legislation.

Let me set the record straight. This year, in accordance with the new law, seniors will receive significant new benefits. Of major importance is that there will be relief when the senior hits the "donut hole." For the first time, there will be a discount on prescription drugs when you hit the donut hole, thereby greatly reducing the cost to many seniors. Further, beginning this year, seniors will be entitled to free screening for various types of cancers as well as for wellness exams.

While these benefits accrue directly to Medicare recipients, our seniors are also concerned about how plans to dismantle the health care legislation, if successful, would impact their children and grandchildren. The new law currently includes:

- •No child can be refused coverage because of a pre-existing condition.
- •Children up to the age of 26 can now be carried on their parent's policies.
- •You cannot be charged extra for emergency medical care if the hospital happens not to be in your insurance company's network.

# Providing healthcare for all is not something we can put off until tomorrow.

- •Coverage can no longer be cancelled just because the policyholder got sick – as has been done.
- •The law sets a percentage of premiums that the insurance company must spend on health care for its insured.
- •Insurance companies can no longer impose an annual maximum or lifetime maximum on benefits they would pay. This is extremely important as we all know that costs associated with cancer and heart disease can easily exceed previous maximum amounts. Many families have been forced to file for bankruptcy

because of these high medical bills.

Other benefits continue to become effective in the years ahead. Knowing these facts, can any of us, especially seniors, sit back and watch the health reform be dismantled?

For the first time, we are on the threshold of seeing millions of our citizens receive needed health care. This certainly should be a basic right of every American. To protect what has already become effective and what will become effective in the near future, it requires all of us to become politically active. For many who have forgone medical treatment, for those suffering long term illness this new legislation provides a much needed lifeline. For everyone, affordable health care defines their quality of life.

All of us working together can win this fight. Providing health care for all is not something we can put off untill tomorrow. It is time for all concerned Americans to let their office holders - at every level of government - know just how they feel about this issue. Our seniors can set the pace by rallying their families for the fight that looms ahead. And, it is certainly time now for all to write to their Members of Congress making it clear that you support the new health care legislation. The time to act is now.

### Tenant Apartment Safety A Focus on Individual Safety from EHDOC

Often, as residents, we look at apartment safety as just being the responsibility of the Community Management Company or the Community Manager. That is just not the case. There are certain factors that simply cannot be monitored or controlled every minute of every day by any management company or its on-site manager. We need every resident to be aware and alert to safety situations. Here are some safety tips that every resident can use to help make sure our properties remain safe.

# **1. Door Locks, Door Chains, and Dead Bolts** Always lock your door and deadlock, if provided, when you leave and after you get home. Do not prop your door open or leave it open for friends or deliveries.

#### 2. Window Locks and Ventilation Locks

Always lock your windows. All first floor windows or windows and sliding doors accessible by a balcony should be kept locked. These locks, when installed and used properly, will not allow entry without breaking glass. If locks are missing or don't work, request repairs immediately.

#### 3. Key Use Policy

Never label your keys or key chain with your house or unit number. If you lose them, your residence will be at risk. If you lose your keys, the manager will have new keys made for you. (You may be required to pay a fee for lost keys.)

### **4. Security Locked (Controlled Access) Entrances**

Controlled entrance doors are only secure if the common doors remain closed and locked when not in use. Remember, if you prop them open, you are compromising the safety of the whole building. Key codes should not be given out, if this applies to your property.

### **5. Sliding Door Locks and Secondary Security Devices**

Unsecured sliding doors are a common target for unauthorized entry. Be sure your patio door lock mechanism locks securely when closed. A secondary locking device such as a broom or mop stick can be placed in the sliding track to prevent the door from opening.

## **6. Common Area/Parking Lot Lighting** If bulbs are burned out, notify the Community Manager right away.

#### 7. Window Coverings

Keep your curtains or blinds closed if you are away from home for an extended period of time. Open window coverings make it easy for an intruder to see that you are either not home or home alone.

#### 8. Door Viewer

Always use your door viewer before you open your door for someone. If the door viewer is broken, notify the Community Manager immediately.

#### 9. Be Aware

In this day and age it seems no one is safe from crime. Remember to be aware of your surroundings. If you spot something that seems to be unusual to the normal setting of your residence, let your Community Manager know.

#### 10. Don't take matters into your own hands

Don't confront anyone that seems out of the ordinary, just tell your Community Manager or a

member of the staff, and they will deal with the situation. Remember to call 911 in emergencies.

### EHDOC Development News

In 2010-2011 EHDOC will invest over \$21 Million into six currently operating EHDOC Communities. Robert Sharp Towers I, Miami Gardens, FL; Johnson Towers, Washington DC; Jacksonville Towers, Jacksonville, AR, Mayfield Manor I, Canton, OH; Teamsters Residence; Maumee, Ohio; and MC Pepper Towers, Miami, FL were the recipients of the funds through special HUD programs and property refinancing.

Part of the \$21 Million came from the American Recovery and Reinvestment Act of 2009, through the Green Retrofit Program. EHDOC successfully applied for and received three grants totaling over \$3.75 Million to make energy and green retrofit improvements to the properties.

Mildred Claude Pepper Towers, a 150 unit community in Miami, Florida is currently under redevelopment as EHDOC's first low-income housing credit refinance. Through the use of tax credits the property will receive a nearly \$8 million dollar renovation that

will include a host of upgrades to the units and common areas. The remainder of the funds came through conventional refinancing.

EHDOC has also been busy with the construction of three new Section 202 communities. We recently completed Ed Romero Terrace in New Mexico and Piazza Apartments in California, creating 40 and 60 new units respectively. Construction has commenced on Edward M Marx apartments, a 33 unit substantial rehab located in Chicago, Illinois.
